Detailed instructions will be published in the Ranked List to be published for the post.Copy of answer scripts of the OMR Test held on **21-06-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8).Candidates belonging to Other Backward Classes in the Short List are required to produce Non CreamyLayer Certificate as per G O (P)No 81/2009/SC/STDD dated 26/09/2009 .SC/ST candidates are required to produce Community Certificate in form III or digitally signed by the Revenue Authority not below the rank of Tahsildar ,EWS certificates in the case of EWS candidates issued by the Revenue authority at the time of OTR Verification of original documents.
