Note :- (6) Candidates belonging to the Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per GO(P) NO. 81/2009/SCSTDD dt.26.09.2009 and SC/ST candidates are required to produce Community Certificate in Form III or digitally signed issued by the revenue authority not below the rank of Tahsildar at the time of One Time Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 07-05-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No. ER II(1)2749/2022/EW dt 31/10/2022.
