Note :- (6) Candidates belonging to SC/ST category included in the Short List are required to produce Community Certificate in Form III or Digitally Signed and those belonging to other reservation groups should produce Non Creamy Layer Certificate as per GO (P) No.81/2009/SC/STDD dated 26/09/2009 issued by village office for State employment purpose at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **28-12-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : .ER II (1) 1211/2022/EW Dated 31/05/2022.
