Note 5. According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note 6. Candidates included in the short list who qualify the Swimming Test are required to produce community Certificate (in form III/ Digitally Signed Certificate) issued by the competent revenue authority not below the rank of Tahsildar as specified in Kerala gazette in case of SC/ ST, and a Non Creamy layer Certificate as per GO (P) No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority in the case of other reservation communities and those who have claimed for EWS reservation are required to produce an EWS Certificate as per GO (Ms) No. 2/2020/P&ARD dated 12.02.2020 at the time of Verification.

Note 7. The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note 8. Copy of answer scripts of the OMR Test held on 13.03.2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
