NOTE (1):- The Ranked List for the post published by the Commission, shall remain in force for a minimum period of one year subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list. In case no candidates is advised from the ranked list till the expiry of the maximum period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier. As the advice of appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the ranked list will secure appointment. The candidates remaining in the ranked list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the ranked list.

NOTE (2):- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of Commission or its photocopy, or downloaded and printed in A4 size paper from the Commissions website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of Rs. 85 (Rupees Eighty Five only) under the Head of Account 0051-PSC-105 State PSC99 – Examination Fee addressed to the District Officer, Kerala Public Service Commission, District Office, Kasaragod – 671121. Applications submitted in any other manner will not be considered. A period of 30 (Thirty) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of upload of the Ranked List in the website. (on or before 16.03.2023). The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Applications for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (3):- Candidates who wish to obtain a photcopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three hundred and thirty five only) in any of the Treasuries in the State (Head of Account: 0051 -PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission District Office, Kasaragod - 671121 within 30 (Thirty) days from the date of upload of the Ranked List in the website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is **16.03.2023** Applications received after the prescribed date will not be entertained.

NOTE (4) :- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Kasargod 671 121 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidates will be advised as incorporated in the Ranked List.

NOTE (5):- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions." The request for relinquishment, along with the original of notarized affidavit and self attested copy of the ID proof, received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised". The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances.

NOTE (6) :- The date of publication of Ranked List in the website is 15.02.2023. This date will be considered only for relinquishment.

NOTE (7): The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the Ranked list ie on **09.02.2023.**
