Note :- (6) Candidates included in the Short List who qualify in **Swimming Test** are required to produce Community Certificate (in form III/ Digitally Signed Certificate issued by the Competent Revenue Authority not below the rank of Tahsildar as specified in Kerala Gazette in case of SC/ ST, and a Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority in the case of other reservation communities and those who have claimed for EWS rsevation are required to produce an EWS Certificate as per G.O(Ms.)No.2/2020/P&ARD, dated 12.02.2020 at the time of Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **13-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
