Note :- (6) Candidates included in the Short List are required to produce Community Certificate in Form III or Digitally signed (for SC/ST Candidates), Non Creamy Layer Certificate as per GO(P)No.81/2009/SC/STDD dated 26/09/2009 for other reservation communities 9for employment purpose from village office)and EWS Certificate who claim EWS issued by the REvenue Athourity at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **22-02-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer Scripts of no candidates are invalidated as per Notification No : **ERVII(1)1578/2022/EW dated 05/05/2022.**
