Note (5): According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note (6): Candidates belonging to Other Backward Classes included in the Unified List are required to produce Non Creamy Layer Certificate as per G.O. (P)No :81/09/SC/ST/DD dated 26/09/2009, Candidates belonging to SC/ST Communities shall upload Community Certificate and Candidates belonging to Economically Weaker Sections shall upload EWS Certificate as per G.O. (MS)No :02/2020/P&ARD dated 12/02/2020 issued by the Revenue authority along with the other documents at the time of OTR Verification.

Note (7): Copy of answer scripts of the OMR Test held on **26-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
