Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to to produce Non Creamy Layer Certificate issued by the Village officer as per GO(P) No 81/09/SCSTDD dated 26/09/2009, Scheduled Caste/Scheduled Tribe candidates included in the Short List are required to produce CommunityCertificate (in form III/digitally signed) issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate rules 2002 by the Revenue authority not below the rank of Tahasildar and candidates belonging to Economically Weaker Section category are required to produce EWS certificate in the format prescribed vide GO(MS)No 02/2020/P&ARD dated 12/02/2020, in proof of their claim along with other relevant documents at the time of OneTime Registration Verification of original documents

Note :- (7) Copy of answer scripts of the OMR Test held on **05-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note:- (8) Vacancies, if any arising against the sub category Blindness/Low Vision, shall not be set apart as enjoined in GO(Rt) No. 389/2019/SJD dated 29/06/2019 and action as contemplated in Lr No. DR3-3/50013/2018-KPSC dtd 24/10/2019 (Decision No. 4 dated 22/10/2019 of the Commission) shall invariably be undertaken.
