Such applications should reach the Deputy Secretary (Examinations)-III, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram - 695004 on or before 22.03.2023 ie., within 15 (Fifteen) days from the date on which this Eligibility List is uploaded in the website of the Commission.
