**FOURTH NCA NOTIFICATION**

Applications are invited online only through “ONE TIME REGISTRATION” scheme from qualified candidates belonging to Scheduled Caste community for appointment in the under mentioned post in Kerala Government Service. Before applying for the post the candidates should register as per One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

1. **Department** : **Collegiate Education**
2. **Name of Post** : **Assistant Professor in Statistics**
3. **Scale of pay** : **UGC Scale**
4. **Number of vacancies** : **Scheduled Caste (SC) - 04 (Four)**

The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above mentioned community but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 10.07.2006 for the post (Gazette Date:17.02.2004, Category No.29/2004). This is the fourth NCA notification for the post owing to the non availability of qualified candidates belonging to the above community as per the following notifications.

5. **Method of appointment** : Direct Recruitment [Only from candidates belonging to Scheduled Caste (SC) community. But the applications of Scheduled Tribe candidates will also be considered in the absence of Scheduled Caste candidates.]  
**Note:** Applications of candidates belonging to communities other than the above will be summarily rejected. Individual rejection memo will not be sent to them.
6. **Age Limit** : **22 - 45**. Only candidates born between 02.01.1978 and 01.01.2001 (both dates included) are eligible to apply (For other conditions regarding age relaxations, please see para (2) of the General Conditions except para 2(i)).
7. **Qualifications** : 1) Masters Degree in the concerned subject with not less than 50% marks or its equivalent and good academic record .  
2) Must have passed a Comprehensive Test in the subject concerned specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.

Note: i) Candidates who have acquired non-qualifying degrees viz.Ph.D/M.Phil/Post Doctoral Fellowship will be awarded weightage marks provided that such non-qualifying degrees shall be in the subjects pertaining to the basic qualification stipulated for the post.Weightage marks for Non-qualifying degrees for ranking will be awarded as detailed below.

Non-Qualifying M.Phil - 2 Marks

Non - Qualifying Ph.D - 4 Marks

Both M.Phil & Ph.D(Non-Qualifying) - 5 Marks

Post Doctoral Fellowship - 2 Marks

- ii) Non-Qualifying degree means the additional qualifications which are earned apart from the qualifications insisted on as essential qualifications for the post.If Ph.D/M.Phil/Post Doctoral Fellowship is reckoned as the essential qualification for the post,weightage marks will not be awarded for it.
- iii) KS & SSR Part II Rule 10 (a) ii is applicable.
- iv) In addition to the qualification prescribed in this notification,the qualifications recognized by executive orders or standing orders of Government as equivalent to the qualification specified for the post, in the Special Rules or found acceptable by the Commission in cases where acceptance of equivalent qualifications is provided for in the rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission.
- v) Candidates who have obtained Ph.D Degree in the subject concerned are exempted from passing the NET examination (G.O.(P)No.86/07/H.Edn dated 19.06.2007).
- vi) The Degrees/Diplomas awarded by UGC approved Universities or Institutions established through an act passed by Parliament/State Legislative Assembly in accordance with the conditions laid down in G.O (M.S) No.526/PD dated 17.07.1965 are acceptable for appointment in Government Services.

#### 8 Mode of submitting Applications:-

- (a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2013.Those candidates who create new profile 01.01.2022 onwards should upload their photograph taken within six months.Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph.The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the Kerala Public Service Commission on request after the last date fixed for the receipt of application will not be reflected in the application.Such correction will come into effect only on the date on which corrections have been made.
- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective

profiles and in the mobile phone number registered in it.

- (c) Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.

**9 Special Instructions to Candidates:**

- (i) In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer/Community Certificate at the time of certificate verification.
- (ii) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- (iii) Appropriate disciplinary action as per **Rule 22 of the Kerala Public Service Commission Rules of Procedure** shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
