Note :- (6) Candidates included in the Probability List are required to produce Non-Creamy Layer Certificate in the case of Other Backward communities ,Community Certificate in the case of SC/ST candidates and EWS Certificate in the case of Economically Weaker Section candidates issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **25-08-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. As per Notification No :ER IV B(2)4323/2022/EW dated 28/03/2023 no Answer Scripts are invalidated for the above mentioned post.
