Note :-(6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :-(7) Candidates included in the Short List are required to produce Non-Creamy Layer Certificate in the case of Other Backward Communities , Community Certificate in the case of SC/ST candidates issued by the Revenue authority and Differently abled candidates are required to produce Disability certificate concerned at the time of OTR verification.

Note :-(8) Copy of answer scripts of the OMR Test held on **03-06-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
