Note :- (6) Candidates included in the Short List are required to produce EWS Certificate/NCLC/Community Certificate issued by the Revenue authority at the time of OTR Verification to prove the claim in application.

Note :- (7) Copy of answer scripts of the OMR Test held on **23-07-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER IX (2) 3476/2022/EW dated 30.11.2022.
