The following is the list of candidates for selection to the post of **CONFIDENTIAL ASSISTANT GRADE II (I NCA - ST)** on **Rs. 20000 - 45800/-** in **VARIOUS DEPARTMENTS** in **ERNAKULAM DISTRICT**, interviewed and found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancies for **Scheduled Tribe** community. This Ranked List is brought into force with effect from **20.05.2023** and will be valid till the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to **Scheduled Tribe** community during the currency of the Mother Ranked List published on 23.05.2016 (Cat No.130/2012).

NOTE (1) :- Since a common Dictation and Transcription test with common candidates were conducted for this post, the marks awarded to the candidates included in the Ranked List will be published only after the publication of entire Ranked List (including NCA Notifications if any) which will be finalized on the basis of the common Dictation test.

NOTE (2) :-According to the existing procedure, revaluation of Answer script is not allowed. OMR Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.kerala.psc.gov.in by remitting the prescribed fee of Rs. 85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie.,on or before 05.06.2023).

NOTE (3):-Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie.,on or before 05.06.2023). Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4) :-The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked List for all the posts finalized on the basis of the common OMR test.

NOTE (5) :- Revaluation/Rechecking/Photocopy of answer script of Dictation Test is not allowed.

NOTE (6) :-The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the **District Officer, Kerala Public Service Commission District Office, Ernakulam**, within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (7) :- The candidates who wish to relinquish their claim for advice from the ranked List shall submit an application in the format prescribed by the Commission to the **District Officer, Kerala Public Service Commission District Office Ernakulam**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

Note (8):-The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of last Ranked list included in the common test held on 08.10.2020.
