(ie,on or before 02/06/2023) Application submitted in any other manner(i.e via email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate.

NOTE (3) :- The entries put in column (9) are based on the Communities specified by the candidate intheirApplication forms and proved by them with necessary documents. The candidate whose Communities have notbeencorrectly noted in the Ranked List as proved by them in their Application should intimate the fact to theDeputySecretary (Examinations) -I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in theRanked List
