The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the **District Officer, Kerala Public Service Commission, District Office, Civil Station (P.O), Kozhikode 673020,** within **30 (Thirty)** days from the date on which this Ranked List is uploaded in the Commissions Website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **08/06/2023**. Applications received after the prescribed date will not be entertained.

NOTE (5):- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the **District Officer**, **KPSC District Office**, **Civil Station (P.O)**, **Kozhikode 673020**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances.
