Note :- (6) Candidates belonging to SC/ST category included in the Probability List are required to produce Community Certificate ( Form III or digitally signed) issued by the Revenue authority and those belonging to other backward community / EWS should produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD Dated 26.09.2009 or EWS certificate as the case may be at the time of OTR Verification.
