A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to Candidates with effect from the Date of Uploading of this Ranked List in the official website of the Commission (on or before 30-06-2023) . Applications submitted in any other manner (ie via email/Tappal /Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets due to any defect will not be issued.

NOTE (5) :- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) -I, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to.
