Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidate who claim EWS reservation are required to produce EWS certificate vide Go No 2/2020 P&ARD dt 12/02/2020 at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **03-03-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
