Note :- (7) The Candidates who are included in the Short List and eligible for reservation, required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009/Community Certificate/EWS Certificate issued by the Revenue authority and shall produce the same along with the other documents at the time of verification of original documents.
