But Answerscripts will berechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.kerala psc.gov.in by remitting the prescribed fee of Rs. 85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered.
