NOTE (1):- The Ranked List shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be inforce if a new list after the expiry of the minimum period of one year is published. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner ,ie ,Email/Tappal/By hand,will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. ie on or before 24/07/2023.) Rechecking of invalidated answer scripts due to any defects will not be considered.

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission (www.keralapsc.gov.in) by remitting the prescribed fee of **Rs. 335** (**Rupees three hundred and thirty five**) via **e-payment** mode available

in the portal. A period of **15 (Fifteen) days** time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission, **ie, on or before 24/07/2023**. Application submitted in any other manner ,ie, **Email/Tappal/By hand**, will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued.

NOTE (4):- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to The District Officer Kerala Public Service Commission, District Office, Civil Station PO, Kannur, 670002. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of uploading of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (5):- Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.
