Note :-(7)Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O(P)No. 81/09/SC/ST/DD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate issued by the concerned authority at the time of OTR verification.

Note :- (8) Copy of answer scripts of the Common OMR Test held on **17-02-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
