Note :- (5) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published in due course.**

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (7) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. EWS Certificate issued by the Revenue authority should be produced by the candidates belonging to Economically Weaker Sections at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **31.05.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER IV (3) 2733/ 2022/EW dated 02/09/2023.
