NOTE (1) :- The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of the Ranked List. As the advice for appointment depends on the occurance of vacancies there is no gauarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

NOTE (2) :-According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts willbe rechecked if the candidates apply through their One Time Registration profile from the Commission's official Website www.keralapsc.gov.in by remitting the prescribed fee of **Rs. 85/- (Rupees Eighty Five Only).** The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of **15** (**Fifteen**) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effectfrom the date on which the Ranked list is uploaded in the website of the Commission. The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Applications submitted through email/by post/in person will not be considered.

NOTE (3) :-Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the commission www.keralapsc.gov.in by remitting the prescribed fee of **Rs.335/- (Rupees Three Hundred and Thirty Five only)** via e payment mode available in the portal. A period of **15 (Fifteen) days** time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked list uploaded in the website of theCommission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheetwhich is not their own, and legal proceedings will be initiated against those who do so. Applications submitted through email/by post/in person will not be considered.

NOTE (4) :-The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission addressed to the District Officer,Kerala Public Service Commission,District Office, Opp. Govt.Guest House Civil Station P O Palakkad 678001. either directly or by post. The format is available in the Official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by a Gazetted Officer of State/Central Government with Signature,Name, Designation and Office Seal along with a notarized affidavit and a self attested Copy of an ID Proof bearing Photograph as enlisted in the General Conditions. The request for relinquishment received within **15 days** from the date of uploading of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (5) :- Since a common OMR test with common candidates was conducted for the post, the marks awarded to the candidates included in the Ranked List will be published only after the publication of entire Ranked Lists .The result of rechecking of OMR answerscript will be intimated in due course, but photocopy of OMR script will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
