Note :- (2) The list has been prepared by including the requisite number of candidates in the Main List who have secured top marks in the OMR Test based on the details furnished by the candidate in the Application and subsequent claim, if any, made will not be entertained at any stage of selection.

Note :- (3) **10 (Ten only) candidates** who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **23.33 (Twenty three (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes , Scheduled Tribes , Other Backward Classes (and other reserved catogories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) The Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated in due course through profile message and SMS.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non-Creamy Layer Certificate issued by Village Officer as per G O (P) No.81/09/SCST DD dated 26/09/2009 and SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of community certificate Rules 2002 by the Revenue authority not below the rank of Tahildar and candidates belonging to Economically Weaker Sections should produce relevant certificate as per G.O.(Ms) No.2/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **07-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script of candidates is invalidated as per ER II (2) 3284/2023/EW Dated 07/09/2023.
