THIRD NCA-NOTIFICATION

Applications are invited online only through One Time Registration from qualified candidates belonging to **Scheduled Tribe** community in the state of Kerala for selection to the undermentioned post in Kerala Government Service. Before applying for the post the candidates should register as per One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

- 1 Department** : **Medical Education**
- 2 Name of Post** : **Assistant Professor in Biochemistry**
- 3 Scale of pay** : **As per UGC norms**
- 4 Number of vacancy** : **Scheduled Tribe-01 (One)**

The above vacancy is now in existence. The Ranked list published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above mentioned community but remain unfilled and also against vacancies that may arise due to the paucity of candidates during the currency of the Ranked List published on 09.08.17 (Cat.No.154/2015). This is the Third NCA notification issued due to the Paucity of qualified candidates belonging to the Scheduled Tribe community after the issuance of the First and Second NCA notifications as given below:

- 5 Method of appointment** : Direct Recruitment from candidates belonging to the **Scheduled Tribe** Community.
- Note:-** Applications submitted by candidates other than the community mentioned above will be rejected. No individual rejection memo will be issued to such candidates.
- 6 Age limit** : **22-50:** (Only candidates born between **02.01.1973** and **01.01.2001** (both dates included) are eligible to apply for the post. (including the age relaxation in para 2(i) of the General Conditions)
- Note:** For other conditions regarding age relaxation please see para (2) of the General Conditions except Para2(i).
- 7 Qualifications** :
i. MD/DNB (Biochemistry)
ii. One year Experience as a Senior Resident in Biochemistry in a NMC Recognized Medical College after acquiring Post Graduate Degree.
iii. Permanent Registration under Kerala State Medical Council (TCMC)/ Council for Modern Medicine.

Note:1 1. KS&SSR Part II Rule 10(a)ii is applicable.

2. In addition to the qualifications prescribed in this notification, the qualifications recognized by executive orders, or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission.

3. Those who are appointed in the post should serve for four (4) years during the first ten (10) years of their service (including the period of training) anywhere in India or any other foreign country under Defence Services connected with Defence, if required. Differently abled candidates and those who have completed 45 years of age are exempted from the above compulsory Military Service.

8. Mode of submitting Application:-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after **31.12.2013**. **Candidates who have created new Profile from 01.01.2023 should upload their Photograph taken within a period of 6 months.** Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the KPSC on request after the last date fixed for the receipt of applications will not be reflected in the application. Such corrections will come into effect only on the date on which corrections have been made.

(b) If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- (c) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.

9 Special Instructions to Candidates :-

(a) In the case of difference in Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.

(b) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.

(c) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
