The following is the list of candidates for selection to the post of **WOMEN CIVIL EXCISE OFFICER (2nd NCA MUSLIM) on Rs 20,000-45800 in EXCISE DEPARTMENT in KOLLAM DISTRICT** found suitable by the Commission and arranged in the order of merit based on the OMR test held on 26/02/2022,Endurance Test held on 31/01/2023,Physical Measurement and Physical Efficiency Test held on 26/05/2023 for recruitment against the NCA vacancies for Muslim Community only.This NCA Ranked List is brought into force with effect from **10.08.2023** and will remain in force until the candidate is advised and appointed against the NCA vacancy arose due to the paucity of candidates belonging to Muslim community during the currency of the mother Ranked List (Category No.261/2014) published on 04.05.2015 and remained unfilled due to the paucity of candidates during the currency of the I-st NCA Ranked List published for the post on 13.02.2019 (Cat. No. 310/2016).

**NOTE (1)** :Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to District Officer,Kerala Public Service Commission,District Office, Kollam.The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions.The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which she is to be advised

**NOTE (2)** :-According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website by remitting the prescribed fee of Rs.85 (Rupees Eighty-Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of **15 (Fifteen) days** time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission **(i.e on or before 31.08.2023)**

**NOTE (3)** :-Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, **www.keralapsc.gov.in** by remitting the prescribed fee of Rs.335 (Rupees Three Hundred and Thirty-Five only) via e-payment mode available in the portal. A period of **15 (Fifteen) days** time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission **(ie.on or before 31.08.2023)**. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

**NOTE (4)** :-The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalization of the all Ranked Lists included in the common test held on 26.02.2022.
