Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the eligible and qualified candidates who have secured top marks in the OMR Test.

Note :- (3) **35 (Thirty five)** eligible and qualified candidates who have secured top most marks in the OMR examination are included in the Main list of this Short list. The mark secured by the last candidate in the main list is **36.67 (thirty six (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically weaker section, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) The Short list is prepared based on the details furnished by the candidate in the application for the post and subsequent claims made will not be entertained at any stage.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date, time and venue of OTR Verification and interview will be published in due course.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short list with out further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/ SCSTDD dated 26.09.2009 or that obtained through e-district project in the format prescribed in G.O(Rt)No.3942 /2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of Issue of Community Certificates Rules, 2002 and the candidates who claim EWS reservation are required to produce EWS certificate vide G.O No. 2/2020 P&ARD dated 12/02/2020 along with other documents mentioned at the time of OTR verification of original documents.

Note :- (9) Copy of answer scripts of the OMR Test held on 29-10-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER VIII(2)4890/2022/EW dated 01.03.2023.**
