Note :- (6) Copy of answer scripts of the OMR Test held on 09-05-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated as per invalidation Notification No:ERXVI(3)3611/2023/EW dated .04.10.2023.
