Note :- (3) **11 (Eleven only ) candidates** who have secured top most marks in the OMR examination are included in the **Main List of the List II Short List**. The marks secured by the last candidate in the Main List of the List II is **74 ( Seventy Four )**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes , Scheduled Tribes , Other Backward Classes (and other reserved categories if any ) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification and Interview. Date, Time and Venue of OTR Verification and Interview will be intimated through SMS and profile message.

Note :- (5) According to the existing procedure, revaluation of Answer Scripts is not allowed but Answer Scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non-Creamy Layer Certificate as per GO(P)No:81/09/SC STDD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of community certificate Rules 2002 by the Revenue authority not below the rank of Tahsildar along with the relevant documents at the time of verification of original documents. Candidates belonging to Economically Weaker Section (EWS) included in this List are required to produce certificate issued by the competent Revenue authority in the format prescribed vide GO(MS) No.02/2020/P&ARD dated 12/02/2020 at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on 19/04/2023 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script of candidates are invalidated as per Notification No. ER II (3) 2313/2023/EW Dated 14/07/2023.

Note :- (8) **Inclusion of register number 132261 in the main list of List I made shall be subject to the result of OA (EKM) No.1635 dated 06/10/2023 of the Hon ble Tribunal.**
