For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes , Scheduled Tribes , Other Backward Classes (and other reserved catogories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List who qualify in the Practical Test (Driving Test) should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non-Creamy Layer Certificate as per GO(P)No:81/09/SC/STDD dated 26.09.2009 and SC/ST candidates included in this list are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section (EWS) included in this List are required to produce certificate issued by the competent Revenue authority along with the other documents mentioned above at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-02-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER XVI (3) 2117/23/EW dated 05/06/2023.**
