Note :- (7) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List.Detailed instructions will be furnished in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. Differently abled candidates are required to produce Medical Certificate at the time of Certificate Verification. Economically weaker sections are required to produce EWS certificate issued by the concerned authority at the time of OTR verification.

Note :- (9) Copy of answer scripts of the Online Test held on 15-05-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
