Applications are invited from qualified **Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile.

- 1 Name of Department** : General Education (DIET)
- 2 Name of post** : Lecturer in Malayalam
(Special Recruitment for ST only)
- 3 Scale of pay** : ₹ 55,200-1,15,300 /-
- 4 No. of Vacancy** : 01 (One)

Note: The above Vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published for this post under the same method of appointment. Advice for appointment will be made for the above vacancy and also for the vacancies reported exclusively for Special Recruitment from Scheduled Tribe during the pendency of the list.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment for Scheduled Tribes only).

Note:- Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 22-45,
Only Candidates born between 02.01.1978 and 01.01.2001 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

- (i) Masters degree with not less than 50% marks in Malayalam Language and Literature from any statutory University established in India.
- (ii) M.Ed Degree with not less than 50% marks with specialization in Language Education or Methods of Teaching Malayalam from any statutory University established in India.
- (iii) Teacher Eligibility Test or National or State Eligibility Test or M. phil or Ph.D in the subject concerned or in Education.

Note 1:- 1) Candidates who have acquired Non-qualifying degrees viz. Ph.D/M.Phil/Post Doctoral

Fellowship will be awarded weightage marks provided that such non-qualifying degrees shall be in the subjects pertaining to the basic qualifications stipulated for the post .Weightage marks for non qualifying degrees for ranking will be awarded as detailed below:

Non-Qualifying M.Phil - 2 Marks
Non-Qualifying Ph.D - 4 Marks
Both M.Phil & Ph.D (Non-Qualifying) - 5 Marks
Post Doctoral Fellowship - 2 Marks

- 2) Non-Qualifying degree means the additional qualifications which are earned apart from the qualifications insisted on as essential qualifications for the post. If Ph.D/M.Phil/Post Doctoral Fellowship is reckoned as necessary qualification for the post, weightage marks will not be awarded for it. Weightage marks will be awarded only to those non-qualifying degrees which are claimed in the application and which are acquired on or before the last date of receipt of applications.

Note 2:- 1) The Degrees / Diplomas awarded by UGC approved Universities or Institutions established through an Act passed by the Parliament/State Legislative Assembly in accordance with the conditions laid down in G.O(M.S) No. 526/PD dated 17.07.1965 are acceptable for appointment in Government Services.

- 2) Rule 10 (a) (ii) of part II of KS&SSR is applicable.
- 3) In addition to the qualifications prescribed in the notification, the qualifications recognized by Executive Orders or Standing Orders of Government as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government Orders declaring equivalent / higher qualifications shall be produced as and when required by the Commission.

9 Those who have Aadhaar Card Should add Aadhaar card as ID proof in their profile.

- 12** The Conditions laid down in paragraphs two, three and twenty five (except the conditions laid down in the Rule 3 (c) of Part II of the Kerala State and Subordinate Service Rules) of General conditions are not applicable to this selection.
- 13** Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 14** If a written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile . Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The period regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

15 Special Instructions to Candidates.

- 1) In the case of difference in Caste / Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Community Certificate at the time of certificate verification.
- 2) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- 3) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written / practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
