The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List.
