NOTE (1):- Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be on the basis of the common test.

A periodof **15 (Fifteen)** days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (on or before 23.02.2024)

.NOTE (4):- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/- (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (on or before 23.02.2024). Application submitted in any other manner will not be considered. A copy ofthe answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued

NOTE (5):-The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to the District Officer, Kerala Public Service Commission, ALAPUZHA. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission willnot be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal alongwith a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment, along with the original of notarized affidavit and self attested copy of an IDproof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of theRanked List. After the publication of Ranked List the request for relinquishment will be considered only if such requestis received on or before the date of receipt of requisition based on which he/she is to be advised
