**NOTE (1)** :- For Online Examination rechecking and revaluation are not allowed . Candidates who wish to obtain a print out of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of **Rs. 335** (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of **15 (Fifteen)** days time to apply for print out of answer sheet will be allowed to candidates witheffect from the date on which the Ranked List is uploaded in the website of the Commission (**ie on or before 07.03.2024**). Application submitted in any other manner (i.e. via email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
