**Note (4):-** Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

**Note (5):-** According to the existing procedure, reevaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note (6):-** Candidates belonging to Other Backward Classes included in the Short List are required to produce NonCreamy Layer Certificate (**for employment purpose**) and SC/ST candidates are required to produce Community Certificate (**Form III or Digitally Signed** ) issued by the Revenue authority at the time of OTR Verification. EWS Certificate issued by the Revenue authority shall be produced by the candidates belonging to Economically Weaker Sections at the time of OTR Verification.

**Note (7):-** The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

**Note (8):-** Copy of answer scripts of the OMR Test held on **18-08-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

**Note (9):-** Answer scripsits of no candidates are invalidated as per notification number ER XIV(3)5109/2023/EW dated on 09.01.2024.
