Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published in due course.**

Note :- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O(P) No. 81/09/SC/ST/DD dated 26.09.2009,candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahisildar and candidates belonging to Economically Weaker Section are required to produce EWS certificate issued by the cocerned authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **02.08.2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer script of no candidates is invalidated as per Notification No .: ER XVI(1)4440/2023/EW Dated 07.11.2023.
