NOTE (1):- 10% of vacancies which are reported to the District Office of the Kerala Public Service Commission will be filled up by candidates selected from Low paid Employees in the Subordinate Services. The rules regarding the reservation of appointment contemplated in the rules 14 to 17 of Part II of Kerala State & Subordinate Service Rules, 1958 are not applicable to appointment by transfer. If sufficient number of candidates are not available to fill up the 10 % reservation quota mentioned above, such vacancies will be filled up by candidates included in the Ranked List prepared for open quota. In case the candidates included in the Ranked List prepared for recruitment By Transfer could not secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of the low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly Vide G.O.(P) No. 39/89/P & ARD dated 08.12.1989 .

NOTE (2) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration Profile from the Commission's official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (i.e., via e-mail/tappal/Direct) will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the Website of the Commission

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the commission, [www.keralapsc.gov.in](http://www.keralapsc.gov.in). by remitting the prescribed Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) via e-payment mode available in the portal. A period of 15(Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner (i.e., via e-mail/tappal/ Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4) :- Since a common OMR Test with common candidates was conducted for this post, the marks awarded to the candidates included in this ranked List and mark of OMR Test relating to all candidates appeared for the Test will be published only after the publication of entire Ranked List (including NCA Notifications) which will be finalised on the basis of the common test. The result of Rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalized on the basis of the common Test.

NOTE (5) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to DISTRICT OFFICER, KERALA PUBLIC SERVICE COMMISSION, DISTRICT OFFICE, KOZHIKODE, 673020. The format is available in the official website of the commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of last Ranked list included in the common OMR test.
