For the purpose of satisfying of rules of reservation of appointments to Scheduled Castes,Scheduled tribes, Other BackwardClasses (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present in person and produce the original documents for Verification and Practical Test (T Test & Road Test). Date,time and Venue of Verification and Practical Test will be informed through Profile Message / SMS

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Community Certificate/NCLC/EWS Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 29-11-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated.
