The Marks secured by the last candidate in the Main List is **57.33 (fifty seven (point) three three)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes,Scheduled Tribes, Other Backward Classes and Economically Weaker Section necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and Interview will be published shortly.** SC/ST candidates should produce Community Certificate and others Non Creamy Layer Certificate at the time of One Time **Verification.**

Note :- (4)Candidates included in the Short List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates included in the Short List are required to produce Community Certificate (Form III/Digitally signed) issued by the competent Revenue Authority and those belonging to Economically Weaker Section(EWS) are required to produce EWS Certificate in the format prescribed vide GO (MS) No.2/2020/P&ARD dated.12.02.2020 in proof of their claim along with other relevant documents.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Copy of answer scripts of the OMR Test held on **03-01-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : ER -2/A2/2/2024-KPSC dated 20.03.2024.
