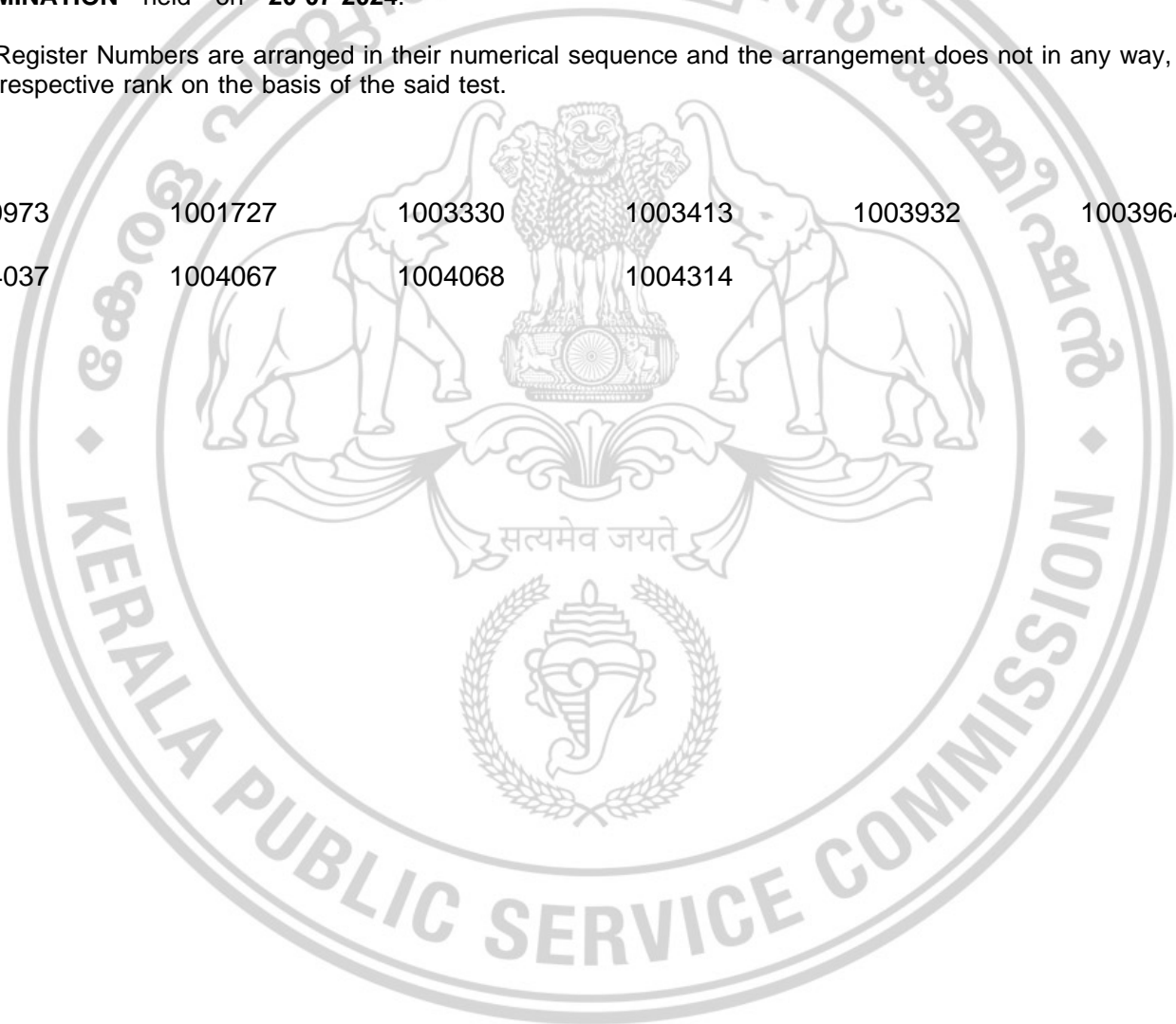

Note :- (7) Copy of answer scripts of the OMR Test held on **20-07-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. As per the Invalidation Notification No.ER 16-3/17/2024-KPSC dated 21.10.2024 of the Secretary ,KPSC ,Thiruvananthapuram , no Answer scripts are invalidated for the above post.
