NOTE (1) :- The Result of the candidate with Register No. 1007057 is withheld.

NOTE (2) :-The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of the Ranked List. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the Ranked List will secure appointment. A period of 15 (fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date on which the Ranked list is uploaded in the website of the commission (ie,on or before 10.05.2025). The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded .Applications submitted through email/by post/in person will not be considered.

NOTE (4):- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration Profile from the official website of the commission www.keralapsc.gov.in by remiting the prescribed fee of Rs. 335/- (Rupees Three Hundred and thirty five only) via e- payment mode available in the portal. A period of 15 (fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the commission (ie, on or before 10.05.2025). A copy of an answer sheet will be issued only once to a candidate.Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.Applications received after the prescribed date will not be entertained. Applications submitted through email/by post/in person will not be considered.

NOTE (5) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) -III, Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (6) - Candidates who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the Commission to THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION, HEAD OFFICE PATTOM, THIRUVANANTHAPURAM-4.
