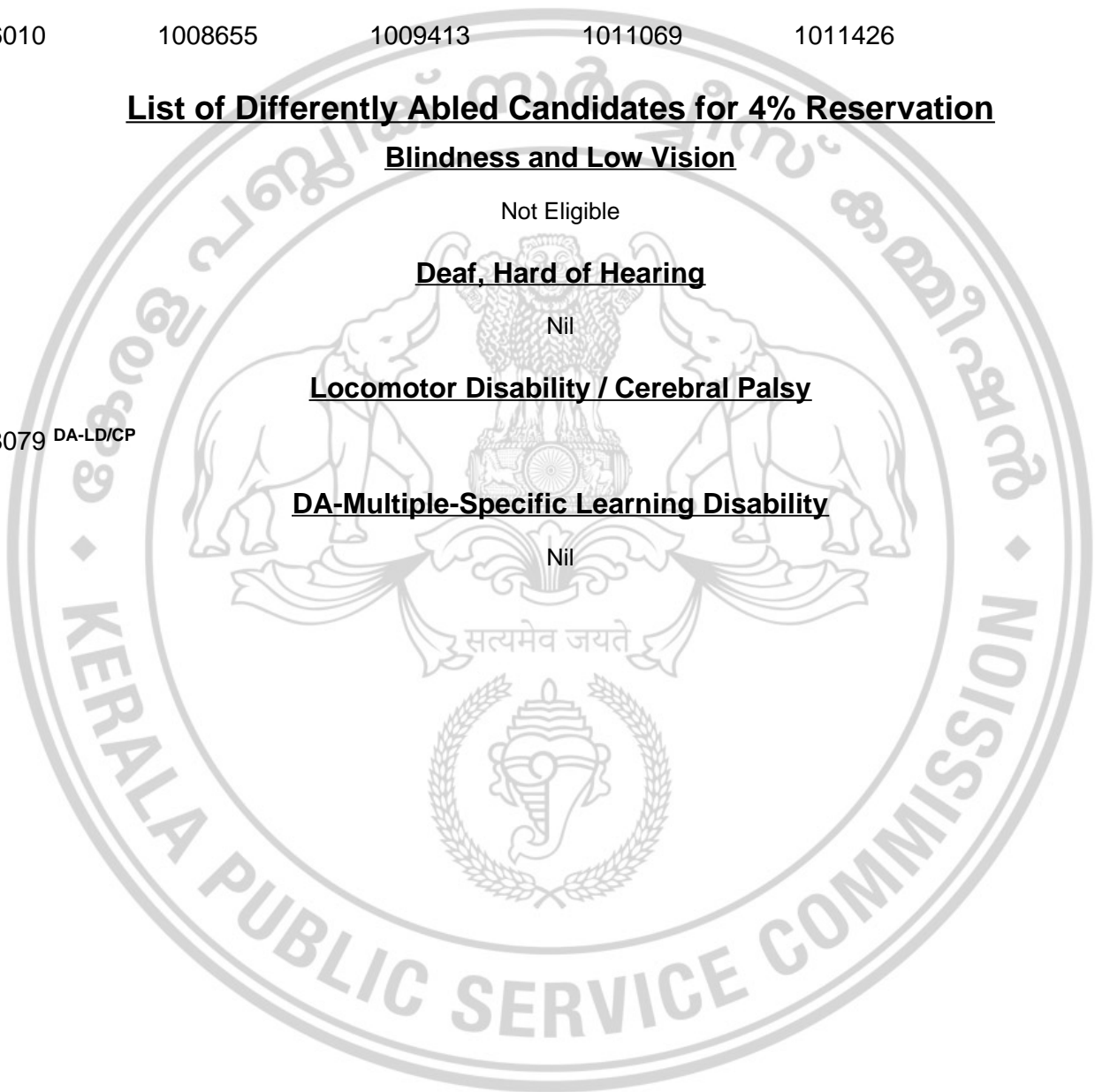

Note :- (2) The list has been prepared based on the details furnished by the candidates in the Application and subsequent claim, if any, made will not be entertained at any stage of selection.

Note :- (3) 10 (Ten) candidates who have secured top most marks in the Common OMR Examination are included in the Main List of this Short List. The Marks secured by the last candidate in the Main List is 72.33 (Seventy Two (point) Three Three) marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories, if any) necessary supplementary lists have been prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification. Date, Time and Venue of One Time Registration Verification will be intimated in due course through profile message and SMS.

Note :- (5) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No. 2/2020/P&ARD Dated. 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the Common OMR Test held on 12-02-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee only after publication of entire Ranked Lists which will be finalized on the basis of Common test. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (7) No answer scripts are invalidated as per Notification No. : ER16-3/3/2025-KPSC Dated 28.03.2025.
