The candidates who have scored **23.25 (Twenty Three (point) Two Five)** marks and above are included in **Part I** and candidates who have scored **37 (Thirty seven)** marks and above are included in **Part II** of the Short List.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification and Interview. **Date,Time and Venue of OTR Verification and Interview will be published shortly.**

Note :- (6) According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Detailed instructions will be published in the Ranked List notification to be published for the post.
