NOTE (1) :- Since a common Online Test with common candidates was conducted for the post, the marks awarded to candidates included in this Ranked List and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked List (including NCA Notifications) which will be finalised on the basis of the common test.

Note (2) :- Rules 14 to 17 of Part II of the Kerala State and Subordinate Service Rules ,1958 are not applicable to appointment By Tranfer Recruitment .

NOTE (3) :- For Online Examination rechecking and revaluation is not allowed. Candidates who wish to obtain print out of Answer sheets to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees three hundred and thirty five only) via e-payment mode available in the portal . A period of 15 (fifteen) days time to apply for printout of answer sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission . Application submitted in any other manner i.e email/Tappal/by hand will not be considered. A printout of Answer sheets will be issued only once to a candidate..

NOTE (4) :- The candidates who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the Commission to THE DISTRICT OFFICER, KERALA PUBLIC SERVICE COMMISSION DISTRICT OFFICE, KOZHIKODE. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of the ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of notarized affidavit and a self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy based on which he/she is to be advised.
