The following is the list of candidates for selection to the post of **FOREST DRIVER (First NCA - Ezhava/Thiyya/Billava)** on **Rs. 19000-43600/- (PR)** in the **Forest Department** in **Thiruvananthapuram District**, found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancies for **Ezhava/Thiyya/Billava** community. The Practical Test was held on **4.03.2025 and 05.03.2025**. This Ranked List is brought into force with effect from **02/05/2025** and will be valid till the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to **Ezhava/Thiyya/Billava** community during the currency of the Mother Ranked List published on **08.06.2021 (Cat No.120/2017)**.

NOTE (1) :- According to the existing procedure, revaluation of answer scripts is not allowed. However, answer scripts will be **rechecked** if candidates apply through their **One Time Registration profile** on the Commission's official website www.keralapsc.gov.in, by remitting the prescribed fee of **Rs. 85/- (Rupees Eighty Five only)** via **e-payment**. Applications submitted in any other manner will not be considered. A period of **15 (Fifteen) days** (i.e., **on or before 20/05/2025**) will be allowed from the date of publication of the Ranked List on the website to apply for rechecking. Applications received after this period will not be considered, and fees once remitted will not be refunded.

NOTE (2) :- Candidates who wish to obtain a **photocopy of their OMR Answer Sheets (Part A & B)** may apply online through their **One Time Registration profile** on the official website by remitting the prescribed fee of **Rs. 335/- (Rupees Three Hundred and Thirty-Five only)** via **e-payment**. A period of **15 (Fifteen) days** from the date of publication of the Ranked List will be allowed for submission of such applications. Applications in any other format will not be entertained. A copy of the OMR answer sheet will be issued only **once** to each candidate. **OMR sheets invalidated due to any defect will not be issued**. Fees once remitted will not be refunded.

NOTE (3) :- Candidates who wish to **relinquish their claim for advice** from the Ranked List shall submit an application in the **prescribed format** available on the official website of the Commission. The request must be attested by a **Gazetted Officer** (State/Central Government) with signature, name, designation, and official seal. It should be submitted along with a **notarized affidavit** and a **self-attested copy of a valid photo ID proof** as listed in the General Conditions. The relinquishment request along with the required documents received **within 15 days** from the date of publication of the Ranked List will be honoured for pending requisitions up to the finalization of the Ranked List. After this, relinquishment requests will be considered only if received **before the requisition date** for advice.

NOTE (4) :- The entries put in column (6) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary, Kerala Public Service Commission, District Office Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (5) :- Since a **common OMR Test** was conducted for this and other posts, **marks awarded to candidates in the Ranked List** will be published only **after the publication of all Ranked Lists** (including those under NCA Notifications) based on the common test.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of the last Ranked list included in the common test.
