Note :- (2) The short list has been prepared by including the number of candidates who have found provisionally eligible, secured top marks in the Descriptive Test based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **12 (Twelve)** candidates who have found provisionally eligible, secured top marks in the Descriptive examination are included in the Main List of this short List. The marks secured by the last candidate in the Main List is **39.25. (thirty nine (point) two five)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the List shall present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be intimated through SMS & Profile message in due course..

Note :- (5) According to the existing procedure, revaluation and rechecking of answer scripts are not allowed.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the list without further notice.

Note :- (7) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate (for state employment purpose) obtained from Village Officer and SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority (Not below the rank of Tahsildar) and candidates who claim EWS reservation are required to produce EWS Certificate as per vide GO(P)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (8) Scanned image and Tabulation sheet of answer scripts of the Descriptive Examination held on 04/12/2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be published in the Ranked List notification to be published for the post. No Candidates are invalidated for this post. See invalidation notification no.
